During the year under audit, the society has acquired fixed assets for Rs.84240.00 under the head Air Conditioner and Software.

2. INCOME AND EXPENDITURE ACCOUNT:

During the year under audit, the society has generated a net surplus of Rs.10148.09 as against the net deficit of Rs.349795.47 generated during the previous year after meeting the administrative and other expenses. The details of expenses of Rs.1600284.91 incurred during the current year ended on 31.3.2020 as against Rs.1750224.67 during the previous year including depreciation as per Income & Expenditure Account attached herewith. This show decrease in expenses by Rs.149939.76 during the current year as compared to previous year. During the year under audit, a major contributor of expenses incurred are under the head Salary to staff, Electricity by Rs.573684.00 and 352689.00 respectively.

The total income of the Society for the year ended 31.03.2020 was increased to Rs.1610433.00 from Rs.1400429.20 for the year ended 31.3.2019 mainly due to increased recovery of rent from shops at R K Puram and income from Recreation Activities, Booking of Community Hall, et. We were informed that the Society is making all efforts to recover pending rent from some ps let out at R K Puram. The total income of Rs.1610433.00 generated during the year ended 31.3.2020 includes Rs.118692.00 from bank interest, Rs.918540.00 from rent, Rs.188100.00 from recreation activities Rs.277700.00 from maintenance of Hall and balance Rs.107491.00 from other sources.

1. During the year under audit, the society has recovered a substantial amount of Rs.423986.00 as against Rs.140010.00 recovered during the previous year. It is requested that all efforts be made to recover Rent from shops let out at R K Puram, New Delhi. 2. The Society has deployed the amount of Reserve Fund in Fixed Deposits with Nationalized

Bank as prescribed in Delhi State Co-operative Rules.

3. As pointed out in our earlier report, all efforts be made to trace out a few files pertaining to the records of the Society which were misplaced and arrange to create parallel files, if possible.

4. All efforts be made to rectify TDS demand of Rs.61280/- at the earliest.

5. The Property Tax demand of Rs.460463/- made by MCD vide its letter no. TAX/A&C/57/RKP/2016/1720 dated 29.12.2016 to be settle with MCD by the society, at the earliest.

#### NOTES ON ACCOUNTS AND ACCOUNTING POLICIES:

I. NOTES ON ACCOUINTS

1. In the opinion of the management of the Society, current assets, loans and advances and investments are approximately of the value stated, if realized in the ordinary course of business. The provision of depreciation and all known liabilities are adequate and not in excess of the amount reasonably necessary.

2. No provision for Income Tax has been made due to absence of any Taxable Income during the

year under audit.

3. Previous Year figures were regrouped or rearranged where ever considered necessary.

#### II. ACCOUNTING POLICIES:

A. Fixed Assets:

Fixed Assets are recorded at cost of acquisition and construction thereto.

B. Depreciation:

Depreciation has been charged on written down value method basis at the rates prescribed by the Income Tax Rules. This is on same basis as in earlier years.

C. Recognition of Income & Expenditures:

Income and expenditure are recognized on cash basis. There is no change in the method of recognition of income and expenditures as compared to previous year.

D. Retirement Benefits:

Provision for retirement benefits in respect of gratuity, leave encasement, etc. has not been made, as not applicable.

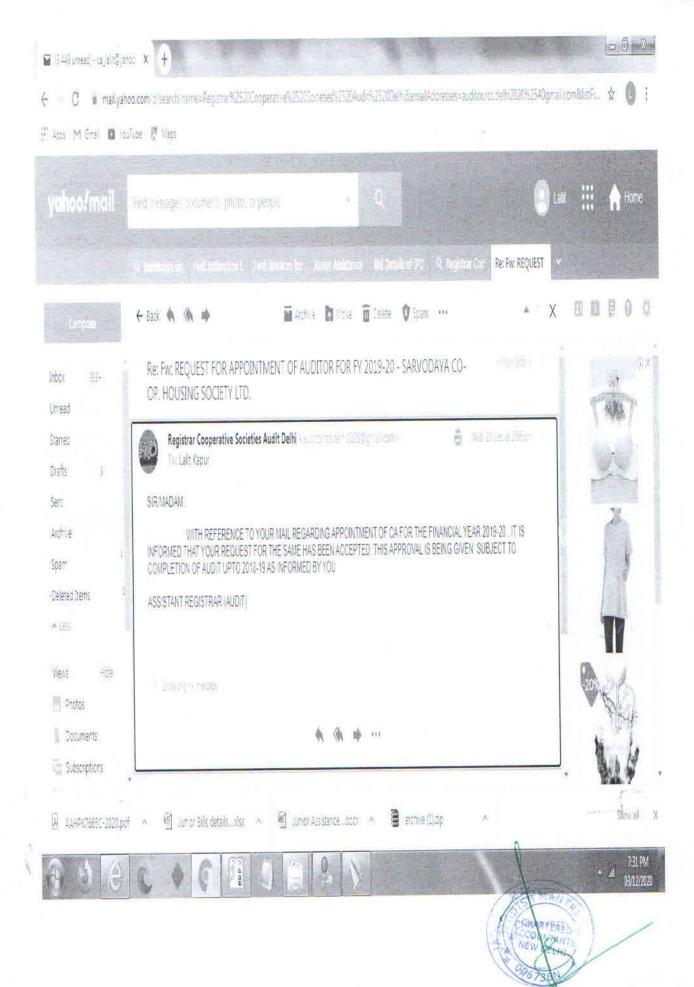
