We have audited the annexed Balance Sheet of Sarvodaya Co-operative Housing Society Ltd., B-74A, Sarvodaya Enclave, Community Centre, New Delhi-110017 as on 31" March, 2021 and Income & Expenditure Account and Receipt & Payment Account annexed thereto for the year ended on that date. These financial statements are the responsibility of the society's management. Our responsibility is to express an opinion on these financial statements based on our audit.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation of these financial statements that give a true and fair view of the financial position, financial performance and cash flows of the Cooperative Society in conformity with the accounting principles generally accepted in India. This responsibility includes the design, implementation and maintenance of internal control relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

Auditors' Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with the Standards on Auditing issued by the Institute of Chartered Accountants o India. The Statutory Reserve Fund represents accumulated amount appropriated out of profits of the Society over the years. Due to losses, the society has not appropriated any amount towards Statutory Reserve Fund during the year under audit.

There has been no change in the balance outstanding under the head Recreation Fund and Share Transfer Fund. The surplus under the head Income & Expenditure A/c has been decreased to Rs.175637.08 as on 31.3.2021 from Rs.304856.99 as on 31.3.2020 due to deficit of Rs.76389.92 incurred during the year, adjustment of IT refund of Rs.57479.00 and provision of Rs.508.00 made for Co-operative Education Fund.

The Lease Fund for Sarvodaya Enclave & Sarvapriya Vihar maintained by the Society separately to control the amount received from the members and payment made on their behalf to DDA towards lease money. The balance outstanding under the head Lease Fund (Sarvodaya Enclave) and Lease Fund (Sarvapriya Vihar) was of Rs.36544.39 and Rs.37219.40 as on 31.03.2021 as against Rs.36443.39 and Rs. 44154.40 as on 31.3.2020 respectively. During the previous year, the society has made any payment to DDA in respect of Lease Fund of Sarva Priya Vihar which was wrongly reported under Lease Money of Sarvodaya Enclave.

The Society has not paid Lease Money Community Centre of of Rs.1/- has not been paid for the past two years.

The Common Good Fund has been maintained by the Society to account for the payment received from member and non-members towards general development of the colony of the Society. During the year under audit, the society has received a contribution of Rs. 200.00 under Common Good Fund. However, the society has not deployed any amount from the head Common Good Fund.

There has been no change in the balance outstanding under the head Rain Water Harvesting Fund during the year under audit.

III. CURRENT LIABILITIES & PROVISIONS:

a) Co-operative Education Fund: Rs.1010/-

The balance outstanding under this head of Rs.1010/- represents Co-operative Education Contribution payable for the year 2020-21 of Rs.508/- and Rs.502/- for the year 2019-20.

During the year under audit, the society has refunded/ written off contribution of Rs.14,000/- received from Community Hall / Centre Booking and Rs. 11,000/- of Security Deposit - Election. The balance outstanding under the head Security Deposit - BTNL is remained unchanged.

During the year under audit, the society has not acquired any fixed asset.

2. INCOME AND EXPENDITURE ACCOUNT:

During the year under audit, the society has incurred a net deficit of Rs.76,389.91 as against the net surplus of Rs.10,148.09 generated during the previous year after meeting the administrative and other expenses. The details of expenses of Rs.11,22,002.76 incurred during the current year ended on 31.3.2021 as against Rs.16,00,284.91 during the previous year including depreciation as per Income & Expenditure Account attached herewith. This show decrease in expenses by Rs.4,78,282.15 during the current year as compared to previous year. During the year under audit, a major contributor of expenses incurred are under the head Salary to staff, Electricity by Rs.4,62,105.00 and 2,04,850.00 respectively.

The total income of the Society for the year ended 31.03.2021 was decreased to Rs.10,45,612.85 from Rs.16,10,433.00 for the year ended 31.3.2020 mainly due to decreased recovery of rent from shops at R K Puram and income from Recreation Activities, Booking of Community Hall, etc. due to Covid 19. We were informed that the Society is making all efforts to recover pending rent from shops let out at R K Puram. The total income of Rs.10,45,612.85 generated during the year ended 31.3.2021 includes Rs.1,43,979.00 from bank interest, Rs.7,06,319.59 from rent, Rs.72,500.00 from recreation activities, Rs.1,07,000.00 from maintenance of Hall and balance Rs.15,814.26 from other sources.

- The accounts of the Society were reconciled with members and with bank periodically, at the end of the Cooperative year with General Cash Book entries.

We were informed that the managing committee has exercised all financial, material management and control to keep the cost of construction of Community Centre as low as possible as far as possible.
 - i. Has the society have been holding meeting of various committees including General Body and proper records of proceedings are being maintained in the minutes/proceeding Register?
 - Yes, as per the information and explanations given to us, the managing committee meetings was held regularly during the year under audit. As per Management, last AGM was held on 29.09.2019.
 - j. List of members with their ledger balances at the close of Cooperative Year a separate list of changes on account of registrations, expulsions and whether rules/instructions in his behalf have been properly complied with?
 - Attached with our Audit Report.
