During the year under audit, the society hasacquired an Attendance Monitoring Software, a Biometric Machine and a Computer.

2. INCOME AND EXPENDITURE ACCOUNT:

During the year under audit, the society has incurred a netdeficitof ₹47,751.37as against the net deficitof ₹1,61,802.35 generated during the previous year after meeting the administrative and other expenses. The details of expenses of ₹19,55,765.55 incurred during the current year ended on 31.3.2024as against ₹13,49,778.46 occurred during the previous year including depreciationas per Income & Expenditure Account attached herewith. This shows increase in expenses by ₹ 6,05,987.09 during the current year as compared to previous year. During the year under audit, a major contributor of expenses incurred are under the head salary to staff, Electricity& Water Exp. and Property Tax of₹8,43,017.00 and ₹2,93,058.00 and ₹4,95,861.00 respectively.

The total income of the Society for the year ended 31.03.2024 was increased to $\stackrel{?}{=}19,08,015.17$ from $\stackrel{?}{=}11,87,976.11$ for the year ended 31.3.2023 mainly due to increased recovery of license fees from shops at R K Puram and income from Recreation octivities, booking of Community Hall, etc. We were informed that the Society is making all efforts to recover pending rent from shops let out at R K Puram. The total income of ₹19,08,015.17 generated during the year ended 31.3.2024includes ₹62,606.00from bank interest, ₹14,11,034.00fromrent,₹7,050.00 from recreation activities and balance of ₹4,27,325.17 from other sources.

- There is no unresolved disputed pending litigation as on date. The new management Committee is however is looking into old legal cases if that could result into any financial gain for the society, will be appealed/ re-initiated.

It is requested that a party wise reconciliation be prepared in respect of rent outstanding from shops at R K Puram, New Delhi for follow up and recoverythereof.

2. The Society has deployed the amount of Reserve Fund in Fixed Deposits with

Nationalized Bank as prescribed in Delhi State Co-operative Rules.

3. As pointed out in our earlier report, all efforts be made to trace out a few files pertaining to the records of the Society which were misplacedand arrange to create rallel files, if possible.

4. Strengthen internal control in the society so that there will be no misappropriation

of cash and property will occur in near future.

5. Society should hold managing committee meeting at regular intervals to review day to day operations of the society. Also hold Annual General Meeting within stipulated time as prescribed.
